

#### **VFW Logo – Maltese Cross**

The Maltese Cross represents a heritage of honor, duty, sacrifice and courage that dates back to the 11th century

The four arms symbolize prudence, temperance, fortitude and justice

The eight points represent the Beatitudes from The Sermon of the Mount

America Scroll says
E Pluribus unum
Out of many, one
The VFW Scroll says
Deo Pro Patria
For God For Country

The vibrant red represents the danger our members have faced

The white represents purity

The gold represents achievements, acts of valor and the unique VFW eligibility status they've earned

# Role of the Inspector



Be Active, connected and engaged with the District Posts

Act as an advisor to the Posts

**Ensure the Post Operates by the Provisions of VFW** 


**Bylaws, Manual of Procedure and rituals** 

**Evaluate the Effectiveness of Post Officers and Procedures** 

Suggest improvements as appropriate

## When can an Inspection Occur?





- Inspections must be completed by December 31 of each year
- District 15 Inspections normally occur during the months of October and/or November of the Calendar Year
- An inspection can occur whenever the District Commander deems it necessary
- ► The District Commander and District Inspector may attend any of a Post's meetings during the year

Where should an Inspection take place?

Inspections should take place at The VFW Post

The Post should be the primary storage location for all records



# Primary Roles and Responsibility Post Commander

Enforce strict observance of the laws and usages of the organization

Insist that Post business and activities be conducted, and do not violate, any applicable law, rule and/or regulation

# Primary Roles and Responsibility Trustee(s)

Review the Monthly Report of receipts and expenditures

Within 30 days from the end of each quarter, audit the books and records of the Post Quartermaster, Post Adjutant and any activity, club room etc. conducted or operated by the Post

# Primary Roles and Responsibility Adjutant

The official corresponding officer for the Post

Prepare all required reports and returns

Maintain all required books and records in a Legible and uniform format

Maintain a current copy of the National and Post By-Laws, Manual of Procedure and Ritual of the VFW

# Primary Roles and Responsibility Quartermaster

Qualify and secure all necessary bonds

**Collect and disburse all Post monies** 

Receive annual membership dues

Reconcile and verify all transactions listed On all bank account statements

#### Feedback from an Inspection







The Post will receive feedback from the inspector as the inspection proceeds



The Inspector will follow-up on any deficiencies and schedule, as necessary, follow-up meeting(s)



Quarterly, the post, will receive the Department Report highlighting any deficiencies that have not been addressed
